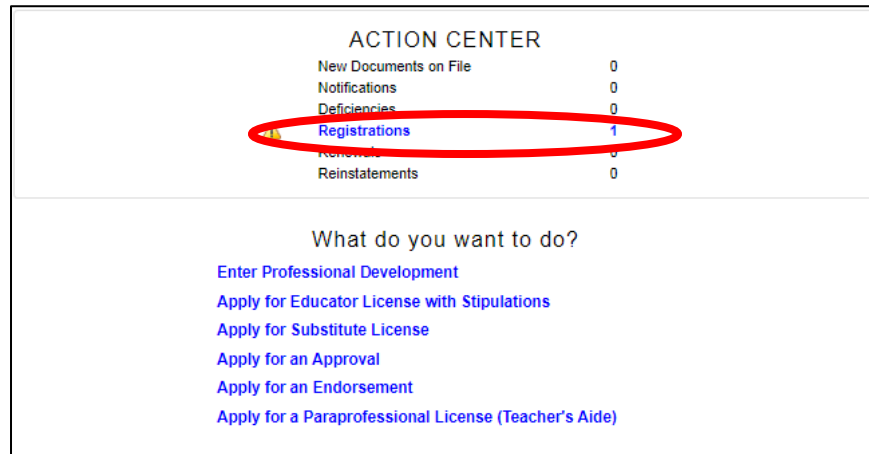

Register Unregistered Licenses

To be valid for employment in an Illinois public or state-operated school, an issued license must be registered in at least one region in the state. After completing the following steps, your license will be registered for its full validity period (for example, a professional educator license will be registered for five years.) Registration fees are \$15 per year and will be collected at the end of the registration process. Any past registration fees that have not been paid will also be collected at this time.
